



Seven Ways to Make a Gift to the Junior Center of Art and Science

Each year the Junior Center serves over 36,000 children through after school and summer classes, school outreach programs, community events, parent/child preschool classes, drop-in activities, and professional development workshops for classroom teachers.

Please consider making a tax-deductible gift to the Junior Center. Your financial support will allow JCAS to continue to provide high quality educational programs, need-based scholarships, expanded art & science based curriculum, and upgrades to its equipment & facility.



1) Outright Gifts:

Outright gifts can include cash or credit card (Visa, Mastercard, American Express or Discover Card can be made online here). All cash gifts are fully tax deductible, up to the maximum of 50% of your adjusted gross income. Excess can be carried over and deducted over as many as five subsequent years.

2) Gifts of Securities:

Gifts of stock or other appreciated property offer two-fold tax savings. Donors pay no capital gains on increased value of the appreciated property and receive an income tax deduction for the full market value at the time of the gift. Transferring securities is easy; however to insure proper tax credit, timely acknowledgement, and accurate processing of your stock donation please contact the Executive Director at (510) 839-5777 for a gift form or more information.

3) Gifts of Real Estate:

Real property, either in entirety or in part, can be deeded to the Junior Center of Art and Science. It is even possible to arrange a sizable tax deduction by deeding a home or farm to the Center now, while continuing to occupy the property for life.

4) Matching Gifts:

Many employers (past or present) participate in a matching gifts program. This is a tremendous benefit that can double or sometimes even triple your gift to the Junior Center. Check with your human resources department for details.

5) Bequests:

In writing your will or living trust, you may specify that you would like a portion of your estate to benefit the Junior Center of Art and Science. You may also specify how you would like your gift to be allocated.



6) Memorial & Honorary Tributes:

A memorial gift to the Junior Center can help perpetuate the values and ideals that guided a loved one's life. Gifts may honor a person during his/her lifetime, or commemorate a significant event. Families of those honored will be sent notification of the donor's gift.

7) Gifts of Trust with Lifelong Income:

You may transfer money, securities or other property in trust of the Junior Center of Art and Science and receive income for yourself (and another) for life. You may receive immediate tax benefits and ultimately the Junior Center will receive the trust property.
